The following list of recommendations is based solely on the results of All-Ukrainian a security survey conducted among judges and court staff from 06 to 26.03.2020.

The following recommendations can be used by a wide range of stakeholders whose powers and capabilities relate to their implementation:

1. Carrying out inspection and inventory of all court premises for security risks and their degree, including the presence / absence of the required number of court security staff, technical equipment, identification of needs for the introduction of additional organizational security measures.

2. Providing all courts with the required number of court security staff to meet identified needs.

3. Establishment of a positive microclimate and interaction in the relations between the judges, the court staff and the court security service staff, in particular, planning professional (official) and extra-official (informal) joint events.

4. Introduction of a psychological support cabinet in the structure of court or of court security service.

5. Introducing a system for systematically informing judges and court staff about the measures taken in court, the possibility of taking security measures outside the court, safe behavior and individual protective measures, means of active defense, providing security recommendations after receiving the appropriate request.

6. Mandatory providing to judges and court staff involved in the case information on infectious and other diseases of the defendant which can be transmitted to other persons and ensuring appropriate security measures, including: temporary detention of defendants in glass docks with ventilation system.

7. Systematic conducting of face-to-face and distance security training for judges and court staff, trainings on the use of personal protective equipment,









provision of pre-medical aid and first aid kit, traumatic kit and automatic defibrillator, training of court security service staff.

8. To identify emergency preparedness, to conduct training under approved emergency scenarios.

9. Conducting a comprehensive analysis of situations (debriefing) of the misconduct of activists on or off court premises, threatening behavior of persons escorted to the court premises as well as other situations that threatened or threaten the activity of the court, judges and court staff.

10. Introducing a clear and effective system for processing threat reports, assessing security threats, selecting and taking adequate security measures (general and/or individual).

11. Installing "duress alarm" in the workplace, courtrooms and smartphones.

12. Arranging controlled access to courtrooms, judges' offices and secure court rooms.

13. Provision of pre-medical aid (first aid kits, traumatic kits and automatic defibrillators).

14. To propose resolving in the team of a specific court the issue of badges indicating medical information, including known allergies and blood types, post-mortem donorship (in any case, such information is a medical secret, part of private life and providing it is the right of the person, not the obligation).
