State Judiciary Administration of Ukraine

Ensures organizational and financial support of the judiciary bodies, as well as:

- Determines the number of judges in the court upon agreement with the HCJ
- Ensures the fulfillment of decisions on establishment and liquidation of courts
- Drafts proposals on court budgets
- Represents the courts in the relations with the Cabinet of Ministers and the President while drafting the law on the State Budget of Ukraine
- Ensures proper conditions for the operation of courts, HQCJU, NSJU and judicial self-government bodies
- Creates conditions to improve professional level of the court staff
- Controls the progress of case management in the courts
- Organizes computerization of courts, ensuring the UCITS operation
- Ensures the e-court implementation
- Ensures the maintenance of the Uniform State Register of Court Decisions, the Register of Electronic Addresses of the state authorities, their officials and officers
- Ensures the functioning of the videoconferencing systems
- Approves the Model Provisions on the Court Staff
- Organizes the operations of the Court Bailiffs Service
- Controls the activities of the Court Bailiffs Service

The highest judicial self-government body during the intervals between the Congresses of Judges, which:

- Convenes the Congress of Judges of Ukraine the regular one once in 2 years or an extraordinary one
- Organizes the implementation of the decisions of the Congress of Judges and their implementation control
- Controls the compliance with the requirements of the law on settling the conflict of interest and regulates it in the activities of the judges, HQCJU Chair or members, Chair of the HCJ and their deputies
- Submits motions on the threats to judges' security
- Submits proposals on approval of the Code of Judicial Ethics
- Carries out actions on the independence of judges and the judiciary, improving the organizational support of the judges' activities
- Considers the matters of legal and social protection of judges
- Carries out control over the organization of judges' activities, listens to the SJA proposals on this matter
- Approves the samples of the judge's ID, retired judge's ID

High Qualification Commission of Judges





Full-time state judiciary authority, which:

- Accounts for judicial vacancies
- Holds competition for filling judicial vacancies - including in the appellate and the Supreme Court
- Selects iudicial candidates
- Organizes special check on judicial candidates
- Holds a qualification examination
- Submits the recommendation on appointing a judge to the HCJ
- Submits a recommendation on the transfer of a judge
- Carries out a qualification assessment
- Maintains the judge's and judicial candidate's dossier
- Determines the needs for state contract and professional training of candidates in the National School of Judges of Ukraine
 - citizens of Ukraine Complete legal education ≥15 years of experience in the field of law
- selected by the Congress of Judges of 8x Ukraine
- appointed by the Ombudsman from among 2x 🚺 persons who are not judges

The tenure of a HQCJU member is 4 years. The person cannot exercise the powers for two terms in a row


